A LOOK BACK AT 2021

mentioned in January that there would not be a rate increase in 2022 since Highline Electric Association had deferred revenue that could be used to offset anticipated losses in 2021 and 2022. You'll remember that deferred revenue is an accounting procedure authorized by HEA's lenders that allows us to set aside part of our revenue in years with strong margins and hold and recognize the revenue in a subsequent year when our margins aren't as strong. While we have not closed the books on 2021, we now have a better idea of where we will end the year. And the news is better than it was in January.

Preliminary financial results indicate operating margins in 2021 of approximately \$250,000 and non-operating margins of at least \$500,000. With these margins, we are able to meet our financial covenants without having to recognize any deferred revenue. We entered 2021 with \$2.4 million in our deferred revenue account. Contingent on Rural Utility Services approval, we will be able to carry all the \$2.4 million balance forward for recognition in future years.

Our 2021 budget contemplated the use of \$1.5 million in deferred revenue in 2021 and \$900,000 in 2022. The ability to carry this deferred revenue forward does a lot to relieve any upward rate pressure we may face in the next few years. There is also good news in the fact that our wholesale power supplier, Tri-State Generation and Transmission Association, has agreed to a 2% rate reduction, scheduled for this month, in the settlement of their rate docket at the Federal Energy Regulatory Commission. Tri-State accounts for anywhere between 72% and 75% of our total expenses, so a rate

reduction from it goes a long way to reduce upward rate pressure.

It's impossible to predict the future, especially given the volatility that COVID-19 has brought to our economy and the fact that there is some risk for upward rate pressure based on the outcome of other dockets that Tri-State has at the FERC. However, our deferred revenue and the wholesale rate reduction should help keep our rates stable over the next few years.

For a complete update on 2021 and a look forward into 2022, plan on attending the HEA Annual Meeting, which is scheduled for March 29 at the Phillips County Events Center in Holyoke. A meal will be served at 5:30 p.m. and the meeting starts at 6:30 p.m. The annual meeting will include the election of directors in four districts. Incumbent directors with terms expiring in 2022 include:

- Leo Brekel in District #1 (comprised of members in Logan, Washington, Weld and Morgan counties)
- Steve Oestman in District #2 (comprised of members in Phillips and Yuma counties)
- Ted Carter in District #3 (comprised of members in Sedgwick and Deuel counties)
- Merl Miller in District #4 (comprised of members in Chase, Dundy and Perkins counties)

I hope you have had a great start to 2022 and I look forward to sharing with you the successes and challenges your cooperative faced in 2021. I hope to see you at the annual meeting; feel free to call or contact me anytime you have questions about your cooperative.



LET US KNOW ABOUT LIFE SUPPORT

If you have anyone on life support systems at your residence, please notify Highline Electric Association. We will try to notify all consumer-members on life support systems of any planned outages. HEA will not terminate a service if a licensed physician makes a certification in writing of a medical emergency. This continuance of service will be effective for 60 days from the date of said medical certification. One 30-day extension may be granted if a second medical certification is received prior to the expiration of the initial continuance period. These provisions may be used only once during any period of 12 consecutive months.

ighline Electric Association's 2022 Annual Meeting is fast approaching. This year marks HEA's 84th anniversary.

If pandemic conditions allow, the meeting will be Tuesday, March 29, 2022, in the Phillips County Event Center at the fairgrounds in Holyoke. Alternate plans will be made if we are unable to gather in person. Consumer-members will receive a direct mailing notice in March with the most up-to-date information regarding the meeting.

HEA Board President Mike Bennett and General Manager Dennis Herman will give their reports on the condition of the association.

This year, an election will be held for four board director positions. These positions require each nominee to be a consumermember of HEA and comply with Article III, Section 3 of the association's bylaws.

There will be one director position from District 1, and the nominees must reside in Logan, Weld, Washington or Morgan county, Colorado. The incumbent director for this district is Leo Brekel.

There will be one director position from District 2, and the nominee must reside in Phillips or Yuma county, Colorado. The incumbent director for this district is Steve Oestman.

There will be one director position from District 3, and the nominee must reside in Sedgwick County, Colorado, or Deuel County, Nebraska. The incumbent director for this district is Ted Carter.

There will be one director position from District 4, and the nominee must reside in Chase, Perkins or Dundy county, Nebraska. The incumbent director for this district is Merl Miller.

Fly Your Drone Safely

Have a new drone? Follow federal guidelines for registering your drone or getting business approval. Take the time to learn about and abide by community and state-specific legislation. Also, keep these Federal Aviation Administration safety guidelines in mind:

- Before flying the drone, check it for damage. Have a damaged drone repaired before use.
- Never fly drones higher than 400 feet.
- Do not fly the drone beyond your line of sight.
- Do not fly near airports, manned aircraft, stadiums or people.
- Do not fly for commercial purposes, unless specifically authorized by the FAA.
- Do not fly in bad weather conditions, such as low visibility or high winds.
- Never fly your drone recklessly. You could be fined for endangering people or other aircraft.
